PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69221 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Loren G. Johnson of 380 Champagne Drive, Roseburg, Oregon 97470, phone 673-5260, for the use of the waters of Champagne Creek, a tributary of the South Umpqua River, for the PURPOSE of irrigation of 3.2 acres,

that the PRIORITY OF THE RIGHT dates from August 6, 1987,

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.04 cubic foot per second.

The POINT OF DIVERSION is to be LOCATED: 365 feet North and 500 feet East from the South Quarter corner of Section 12, being within the SW1/4 SE1/4 of Section 12, Township 27 South, Range 7 West, W.M., in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 27 South, Range 7 West, W.M., Section 12 SW1/4 SE1/4 3.2 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, being further limited during the period July 15 through September 30 of each year to the irrigation of a noncommercial garden not to exceed one-half acre in area and shall conform to such reasonable rotation as may be ordered by the proper state officer.

Actual construction work shall begin on or before June 23, 1989, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1990.

Complete application of the water to the proposed use shall be made on or before October 1, 1991.
