## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 69399 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to International Paper Company, Kellogg Forest Tree Nursery of 1940 Madison Road, Oakland, Oregon 97462, phone 459-5903, for the use of the waters of the Umpqua River and Galesville Reservoir constructed under\* for the PURPOSE of Commercial nursery use to include irrigation during the period October 1 through March 31 of each year when water can be put to beneficial use for immediate crop growth or to raise the soil moisture content to be utilized\*\* that the PRIORITY OF THE RIGHT dates from October 9, 1987

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 10.9 cubic feet per second.

The POINT OF DIVERSION is to be LOCATED: (1): 60 feet North and 410 feet West from the Southeast corner of Section 30; (2): 1980 feet North and 670 feet West from the Northeast corner of DLC 42, being within (1): SE1/4 SE1/4 of Section 30; (2): NW1/4 SW1/4 of Section 20, both in Township 23 South, Range 7 West, W.M.;\*\*\*
