are hereby issued a permit to use waters from SISLEY CREEK, A TRIBUTARY OF THE BURNT RIVER for IRRIGATION OF 18.5 ACRES and the supplemental irrigation of 14.9 acres. The permit has been issued under Application 69421 with a date of priority of October 21, 1987.

This permit is limited to an amount of water that may be beneficially used not to exceed 0.83 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

NE 1/4 SW 1/4, Section 20, T 12 S, R 44 E, WM; 2400 FEET NORTH & 1500 FEET EAST FROM NW CORNER, SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The permittee shall, prior to commencing the diversion of water under this permit, install a regulating headgate and measuring device approved by the watermaster. Provided further that the appropriation allowed herein shall be subject to the proper maintenance of said headgate and measuring device.

Actual construction work shall begin on or before July 18, 1989, and be completed on or before October 1, 1990. Complete application of the water to the use shall be made on or before October 1, 1991.

This permit is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.

This appropriation is subject to minimum flows established by the Water Resources Commission with an effective date prior to this permit.
