PERMIT TO APPROPRIATE THE PUBLIC WATERS

is hereby issued a permit to use the waters from NORTH UMPQUA RIVER, A TRIBUTARY OF UMPQUA RIVER for DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 2.1 ACRES. The permit to the use of these waters has been issued under Application 69386 with a date of priority of OCTOBER 2, 1987. The permit is limited to not more than 0.031 CUBIC FOOT PER SECOND, BEING 0.005 CFS FOR DOMESTIC AND 0.026 CFS FOR IRRIGATION or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

NE 1/4 SW 1/4, Section 13, T 26 S, R 4 W, WM;
300 FEET NORTH & 540 FEET WEST FROM SE CORNER, NE SW,
SECTION 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The place of use is as follows:

Actual construction work shall begin on or before August 29, 1989, and shall be completed on or before October 1, 1990. Complete application of the water to the use shall be made on or before October 1, 1991.

This permit is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
