are hereby issued a permit to use the waters from SOUTH DEER CREEK, TRIBUTARY OF DEER CREEK for IRRIGATION OF 1.56 ACRES. The permit to the use of these waters has been issued under Application 69515 with a date of priority of NOVEMBER 30, 1987. The permit is limited to not more than 0.02 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

NE 1/4 NE 1/4, Section 2, T 28 S, R 5 W, WM; 535 FEET SOUTH & 95 FEET WEST FROM NE CORNER, SECTION 2.

NE 1/4 NE 1/4, Section 2, T 28 S, R 5 W, WM; point 2 560 FEET SOUTH & 30 FEET WEST FROM NE CORNER, SECTION 2.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year being further limited during the period July 15 through September 30 of each year to the irrigation of a noncommercial garden not to exceed one-half acre on area and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The place of use is as follows:

Total: 1.56 acres.

Actual construction work shall begin on or before August 29, 1989, and shall be completed on or before October 1, 1990. Complete application of the water to the use shall be made on or before October 1, 1991.
