### PERMIT TO APPROPRIATE THE PUBLIC WATERS

is hereby issued a permit to use the waters from CONROY CREEK, A TRIBUTARY OF SUMMIT CREEK AND SUMMIT CREEK, A TRIBUTARY OF MALHEUR RIVER for ROAD WATERING. The permit to the use of these waters has been issued under Application 62559 with a date of priority of SEPTEMBER 8, 1981. The permit is limited to not more than 1.0 CUBIC FOOT PER SECOND, NOT TO EXCEED 3,600.0 CUBIC FEET PER DAY FROM SUMMIT CREEK AND NOT TO EXCEED 7,200.0 CUBIC FEET PER DAY FROM CONROY CREEK or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

point (1) SE 1/4 SW 1/4, Section 20, T 16 S, R 34 E, WM;  
1300 FEET NORTH & 2300 FEET EAST FROM SW CORNER, SECTION 20.

point (2) NE 1/4 NE 1/4, Section 19, T 16 S, R 34 E, WM;  
900 FEET SOUTH & 800 FEET WEST FROM NE CORNER, SECTION 19.

point (3) NW 1/4 NE 1/4, Section 17, T 16 S, R 34 E, WM;  
900 FEET SOUTH & 1900 FEET WEST FROM NE CORNER, SECTION 17.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before September 27, 1989, and shall be completed on or before October 1, 1990. Complete application of the water to the use shall be made on or before October 1, 1991.

This permit is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
