## PERMIT TO APPROPRIATE THE PUBLIC WATERS

U.S. MALHEUR NATIONAL FOREST 139 NE DAYTON STREET JOHN DAY, OREGON 97845 503-575-1731

is hereby issued a permit to use the waters from SHEEP GULCH AND BEAR CREEK, A TRIBUTARY OF LITTLE MALHEUR RIVER for ROAD WATERING. The permit to the use of these waters has been issued under Application 62570 with a date of priority of SEPTEMBER 8, 1981. The permit is limited to not more than 1.0 CUBIC FOOT PER SECOND, NOT TO EXCEED 5,400.0 CUBIC FEET PER DAY FROM SHEEP GULCH AND NOT TO EXCEED 21,600.0 CUBIC FEET PER DAY FROM BEAR CREEK or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

- point (1) SE 1/4 NW 1/4, Section 16, T 16 S, R 36 E, WM; 1500 FEET SOUTH & 1900 FEET EAST FROM NW CORNER, SECTION 16.
- point (2) NW 1/4 SW 1/4, Section 15, T 16 S, R 36 E, WM; 2000 FEET NORTH & 800 FEET EAST FROM SW CORNER, SECTION 15.
- point (3) SW 1/4 SE 1/4, Section 32, T 15 S, R 36 E, WM; 100 FEET NORTH & 2400 FEET WEST FROM SE CORNER, SECTION 32.
- point (4) SE 1/4 SE 1/4, Section 5, T 16 S, R 36 E, WM; 1100 FEET NORTH & 300 FEET WEST FROM SE CORNER, SECTION 5.
- point (5) NW 1/4 NW 1/4, Section 23, T 16 S, R 36 E, WM; 900 FEET SOUTH & 100 FEET EAST FROM NW CORNER, SECTION 23.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.
