is hereby issued a permit to use the waters from STATION CREEK, A TRIBUTARY OF NORTH FORK MALHEUR RIVER for ROAD WATERING. The permit to the use of these waters has been issued under Application 62590 with a date of priority of SEPTEMBER 8, 1981. The permit is limited to not more than 1.0 CUBIC FOOT PER SECOND, NOT TO EXCEED 10,800.0 CUBIC FEET PER DAY or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

point (1) SE 1/4 SW 1/4, Section 24, T 16 S, R 35 E, WM;
600 FEET NORTH & 2400 FEET EAST FROM SW CORNER, SECTION 24.

point (2) NW 1/4 NE 1/4, Section 24, T 16 S, R 35 E, WM;
300 FEET SOUTH & 2300 FEET WEST FROM NE CORNER, SECTION 24.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
