is hereby issued a permit to use the waters from RATTLESNAKE CREEK, A TRIBUTARY OF HARNEY BASIN for ROAD WATERING. The permit to the use of these waters has been issued under Application 62620 with a date of priority of SEPTEMBER 10, 1981. The permit is limited to not more than 1.0 CUBIC FOOT PER SECOND, NOT TO EXCEED 5,400 CUBIC FEET PER DAY or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

NE 1/4 NW 1/4, Section 32, T 21 S, R 32.5 E, WM;
1000 FEET SOUTH & 2300 FEET EAST FROM NW CORNER, SECTION 32.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The place of use is as follows:
