is hereby issued a permit to use the waters from BLUE BUCKET CREEK, A TRIBUTARY OF MALHEUR RIVER AND MALHEUR RIVER for ROAD WATERING. The permit to the use of these waters has been issued under Application 62630 with a date of priority of SEPTEMBER 10, 1981. The permit is limited to not more than 1.0 CUBIC FOOT PER SECOND, NOT TO EXCEED 5,400 CUBIC FEET PER DAY FROM EACH SOURCE or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

point (1) NE 1/4 SW 1/4, Section 13, T 18 S, R 34 E, WM;
1500 FEET NORTH & 1400 FEET EAST FROM SW CORNER, SECTION 13.

point (2) SW 1/4 NW 1/4, Section 5, T 18 S, R 35 E, WM;
1400 FEET SOUTH & 1200 FEET EAST FROM NW CORNER, SECTION 5.

point (3) NE 1/4 SW 1/4, Section 19, T 19 S, R 34 E, WM;
2500 FEET NORTH & 1400 FEET EAST FROM SW CORNER, SECTION 19.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.
