is hereby issued a permit to use the waters from UNNAMED TRIBUTARIES OF BLUEBUCKET CREEK AT THE MOFFITT SPRING, JONES SPRING 1 AND JONES SPRING 2 SITES for LIVESTOCK. The permit to the use of these waters has been issued under Application 67483 with a date of priority of OCTOBER 11, 1983. The permit is limited to not more than 0.016 CUBIC FOOT PER SECOND, BEING 0.01 CFS FROM EACH SOURCE, PROVIDED THE TOTAL QUANTITY DIVERTED FROM ALL SOURCES DOES NOT EXCEED 0.016 CFS or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

point (1) LOT 2, NW 1/4 NE 1/4, Section 6, T 18 S, R 35 E, WM; 1200 FEET SOUTH & 2400 FEET WEST FROM NE CORNER, SECTION 6.

point (2) LOT 4, NW 1/4 NW 1/4, Section 6, T 18 S, R 35 E, WM; 300 FEET SOUTH & 600 FEET EAST FROM NW CORNER, SECTION 6.

point (3) LOT 4, NW 1/4 NW 1/4, Section 6, T 18 S, R 35 E, WM; 25 FEET SOUTH & 600 FEET EAST FROM NW CORNER, SECTION 6.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The place of use is as follows:

Actual construction work shall begin on or before October 10, 1989, and shall be completed on or before October 1, 1990. Complete application of the water to the use shall be made on or before October 1, 1991.
