is hereby issued a permit to use the waters from WEST BRANCH ASH SWALE AND BURR RESERVOIR TO BE CONSTRUCTED UNDER APPLICATION R-69474, PERMIT R-11006, for IRRIGATION OF 25.39 ACRES. The permit to the use of these waters has been issued under Application 69400 with a date of priority of OCTOBER 9, 1987. The permit is limited to not more than 0.32 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

NE 1/4 NE 1/4, Section 34, T 6 S, R 5 W, WM; 350 FEET SOUTH & 1320 FEET WEST FROM NE CORNER, SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.
