is hereby issued a permit to use the waters from CONNER'S CREEK & RESERVOIR 1 CONSTRUCTED UNDER PERMIT R-5014, & RESERVOIR 2 TO BE CONSTRUCTED UNDER APPLICATION R-69544, PERMIT R-11011, TRIBUTARIES OF DAVIS CREEK, for IRRIGATION AND TEMPERATURE CONTROL ON 18.83 ACRES; AND FLOOD HARVESTING ON 10.0 ACRES.

The permit to the use of these waters has been issued under Application 69545 with a date of priority of MARCH 3, 1988. The permit is limited to not more than 2.82 CUBIC FEET PER SECOND, BEING 0.47 CFS FOR IRRIGATION, 2.82 CFS FOR TEMPERATURE CONTROL AND 0.5 CFS FOR FLOOD HARVESTING or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

point (1) SE 1/4 SW 1/4, Section 12, T 30 S, R 15 W, WM;
860 FEET NORTH & 320 FEET WEST OF SE CORNER, SESW, SECTION 12.

point (2) SE 1/4 SW 1/4, Section 12, T 30 S, R 15 W, WM;
520 FEET NORTH & 920 FEET WEST FROM SE CORNER, SESW, SECTION 12.

The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control on forms furnished by the department.

If for irrigation of cranberries, this appropriation shall be limited to ONE-FOURTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. If for the irrigation of any other crop, this appropriation shall be limited to ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This permit is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
