### PERMIT TO APPROPRIATE THE PUBLIC WATERS

is hereby issued a permit to use the waters from SILETZ RIVER, A TRIBUTARY OF PACIFIC OCEAN, for IRRIGATION OF 20.6 ACRES AND LIVESTOCK. THE USE ALLOWED HEREIN FOR IRRIGATION MAY BE MADE ANYTIME BETWEEN APRIL 1 & NOVEMBER 30 OF EACH YEAR WHEN WATER CAN BE PUT TO BENEFICIAL USE FOR IMMEDIATE PLANT GROWTH. The permit to the use of these waters has been issued under Application 69493 with a date of priority of NOVEMBER 25, 1987, FOR 30 GPM FOR IRRIGATION; NOVEMBER 21, 1988, FOR 85.9 GPM FOR IRRIGATION AND JANUARY 19, 1989, FOR 0.5 GPM FOR LIVESTOCK. The permit is limited to not more than 116.4 GALLONS PER MINUTE, BEING 115.9 GPM FOR IRRIGATION AND OUT OF SEASON IRRIGATION AND 0.5 GPM FOR LIVESTOCK or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

SW 1/4 SE 1/4, Section 33, T 9 S, R 9 W, WM;  
50 FEET NORTH & 680 FEET EAST FROM S1/4 CORNER, SECTION 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the period from April 1 to September 30, and shall be further limited to a diversion of not to exceed 0.5 acre foot per acre for each acre irrigated during the period from October 1 to November 30, provided further the right allowed herein, together with the amount secured under any other right existing for the same land shall not exceed 2 1/2 acre feet for each acre irrigated in any one year.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The place of use is as follows:

Actual construction work shall begin on or before February 27, 1990, and shall be completed on or before October 1, 1990. Complete application of the water to the use shall be made on or before October 1, 1991.

This permit is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
