## PERMIT TO APPROPRIATE THE PUBLIC WATERS

is hereby issued a permit to use the waters from CONNER'S CREEK, A TRIBUTARY OF DAVIS CREEK AND RESERVOIR TO BE CONSTRUCTED UNDER APPLICATION R-69549, PERMIT R-11036, for IRRIGATION, FLOOD HARVESTING OF CRANBERRIES AND TEMPERATURE CONTROL ON 26.0 ACRES. The permit to the use of these waters has been issued under Application 69550 with a date of priority of MARCH 9, 1988. The permit is limited to not more than 3.9 CUBIC FEET PER SECOND, BEING 0.65 CFS FOR IRRIGATION, 1.3 CFS FOR FLOOD HARVESTING AND 3.9 CFS FOR TEMPERATURE CONTROL or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

NE 1/4 NW 1/4, Section 13, T 30 S, R 15 W, WM; 28 FEET SOUTH & 205 FEET WEST FROM NE CORNER, NE1/4 NW1/4, SECTION 13.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

If water is used for the irrigation of cranberries, this appropriation shall be limited to ONE-FORTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. If water is used for the irrigation of any other crop, this appropriation shall be limited to ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control on forms furnished by the department.

Actual construction work shall begin on or before February 27, 1990, and shall be completed on or before October 1, 1990. Complete application of the water to the use shall be made on or before October 1, 1991.

This permit is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
