## PERMIT TO APPROPRIATE THE PUBLIC WATERS

is hereby issued a permit to use the waters from DENT CREEK, A TRIBUTARY OF DREWS CREEK, for ROAD WATERING. The permit to the use of these waters has been issued under Application 59977 with a date of priority of APRIL 11, 1980. The permit is limited to not more than 84,000 GALLONS PER YEAR or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

SE 1/4 NW 1/4, Section 6, T 39 S, R 17 E, WM; 1131 FEET NORTH & 1510 FEET EAST FROM W1/4 CORNER, SECTION 6.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The place of use is as follows:

Water will be used on Road 394.

In addition the permit is further conditioned to reflect an agreement between the Lakeview Water Users and the U.S. Forest Service:

a). Any diversion of water for road watering by the U.S. Forest Service from a stream tributary to Lakeview Water Users system shall only occur after the U.S. Forest Service gives prior notice to the Manager of the Lakeview Water Users, which notice can be in writing or by telephone.

b). The U.S. Forest Service expressly acknowledges that the utilization of water in Drews Creek channel between Drews Dam and the diversion of the south canal shall not effect the Lakeview Water Users right to control those waters released from Drews Dam into the natural stream of Drews Creek between the outlet at Drews Dam and the diversion to the south canal of the Lakeview Water Users or any new diversion point established to supply water to the south canal.

Actual construction work shall begin on or before March 14, 1990, and shall be completed on or before October 1, 1990. Complete application of the water to the use shall be made on or before October 1, 1991.

This permit is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
