is hereby issued a permit to use the waters from THREE UNNAMED STREAMS, TRIBUTARIES OF NORTH SLOUGH, for DOMESTIC USE FOR TWO FAMILIES, LIVESTOCK WATERING AND IRRIGATION OF 35.0 ACRES. The permit to the use of these waters has been issued under Application 69577 with a date of priority of APRIL 1, 1988 for domestic and stock and June 9, 1988 for irrigation. The permit is limited to not more than 0.4462 CUBIC FOOT PER SECOND, BEING 0.0025 FOR DOMESTIC FROM STREAM 1, 0.0062 CFS FOR LIVESTOCK AND 0.0125 CFS FOR IRRIGATION FROM STREAM 2, AND 0.425 CFS FOR IRRIGATION FROM STREAM 3, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

- point (1) SW 1/4 SW 1/4, Section 36, T 23 S, R 13 W, WM;
SOUTH 62 FEET FROM S1/16 CORNER, SECTION 36
- point (2) SW 1/4 SW 1/4, Section 36, T 23 S, R 13 W, WM;
SOUTH 36 DEGREES EAST 132 FEET FROM S1/16 CORNER, SECTION 36.
- point (3) NE 1/4 NW 1/4, Section 36, T 23 S, R 13 W, WM;
NORTH 42 DEGREES EAST 2700 FEET FROM S1/16 CORNER, SECTION 36.
- point (4) SE 1/4 NW 1/4, Section 36, T 23 S, R 13 W, WM;
NORTH 59 DEGREES EAST 1540 FEET FROM S1/16 CORNER, SECTION 36.
- point (5) SW 1/4 NW 1/4, Section 36, T 23 S, R 13 W, WM;
NORTH 82 DEGREES EAST 1160 FEET FROM S1/16 CORNER, SECTION 36.
- point (6) SW 1/4 SW 1/4, Section 36, T 23 S, R 13 W, WM;
SOUTH 40 DEGREES EAST 1740 FEET FROM S1/16 CORNER, SECTION 36.
- point (7) SE 1/4 SW 1/4, Section 36, T 23 S, R 13 W, WM;
SOUTH 39 DEGREES EAST 2680 FEET FROM S1/16 CORNER, SECTION 36.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before April 18, 1990, and shall be completed on or before October 1, 1991. Complete application of the water to the use shall be made on or before October 1, 1992.

This permit is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
