THIS PERMIT IS HEREBY ISSUED TO

to use the waters of EFFLUENT WATER FROM THE CITY OF HUNTINGTON SEWAGE TREATMENT PLANT, a tributary of BURNT RIVER, for SUPPLEMENTAL IRRIGATION OF 26.7 ACRES.

This Permit is issued approving Application 65281. The date of priority is APRIL 25, 1986. The use is limited to not more than 0.67 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NE 1/4, NE 1/4 NE 1/4, SECTION 18, T 14 S, R 45 E, W.M.; EFFLUENT DISCHARGE POINT - 1722 FEET NORTH AND 780 FEET EAST FROM THE SW CORNER, SW 1/4 NE 1/4, SECTION 18; BURNT RIVER - 450 FEET NORTH AND 50 FEET EAST FROM THE SW CORNER, NE 1/4 NE 1/4 SECTION 18.

The amount of secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that although declared herein to be for supplemental irrigation, in the interest of proper operation of the treatment plant, use of water under this permit may be excercised at times when water is available at the primary all sources of supply does not exceed the limitation allowed herein.

When in the judgement of the watermaster it becomes necessary to measure and keep a record of the amount of water being discharged into the river and diverted from the river, the right allowed herein shall be subject to the installation and maintenance of in-line flow meters, weirs, or other suitable devices approved by the watermaster for measuring the water.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the Permit is as follows:

NE 1/4 NE 1/4 8.7 ACRES

NW 1/4 NE 1/4 1.8 ACRES

SW 1/4 NE 1/4 0.2 ACRE

SE 1/4 NE 1/4 16.0 ACRES

SECTION 18

TOWNSHIP 14 SOUTH, RANGE 45 EAST, W.M.

Actual construction work shall begin on or before August 11, 1990, and shall be completed on or before October 1, 1991. Complete application of the water to the use shall be made on or before October 1, 1992.

This permit is for the beneficial use of water without waste. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
