PERMIT TO APPROPRIATE THE PUBLIC WATERS

is hereby issued a permit to use the waters from NORTH SANTIAM RIVER AND DETROIT RESERVOIR CONSTRUCTED UNDER PERMIT R-1625, TRIBUTARIES OF SANTIAM RIVER, for IRRIGATION AND SUPPLEMENTAL IRRIGATION OF 203.0 ACRES. The permit to the use of these waters is issued under Application 69751 with a date of priority of NOVEMBER 8, 1988 FOR USE FROM RIVER AND JUNE 28, 1989 FOR USE FROM RESERVOIR. The permit is limited to not more than 1.92 CUBIC FEET PER SECOND FROM NORTH SANTIAM RIVER FOR IRRIGATION OF TRACT 1 (153.6 ACRES) AND USE OF NOT MORE THAN 507.5 ACRE-FeET ANNUALLY FROM DETROIT RESERVOIR FOR SUPPLEMENTAL IRRIGATION OF TRACT 1 AND TRACT 2 (49.4 ACRES), or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

1 NW 1/4 SE 1/4, Section 20, T 9 S, R 1 W, WM;
1320 FEET NORTH & 2160 FEET WEST FROM SE CORNER, SECTION 20.

2 SE 1/4 SW 1/4, Section 20, T 9 S, R 1 W, WM;
1230 FEET NORTH & 310 FEET WEST FROM S1/4 CORNER, SECTION 20.

RESERVOIR SW 1/4 NW 1/4, Section 7, T 10 S, R 5 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use of water under this permit is subject to the terms and conditions of Contract No. 9-07-10-W0745 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
