## PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

GARY E. SMITH 1075 KENTUCK WAY NORTH BEND, OREGON 97459 503-756-2483

to use the waters from UNNAMED STREAMS 1, 2, 3, 4, 5 AND 6, and a reservoir to be constructed under Application R-69228, Permit R-11155, TRIBUTARIES OF KENTUCK SLOUGH, for DOMESTIC USE FOR FIVE FAMILIES, INCLUDING IRRIGATION OF LAWN & GARDEN, NOT TO EXCEED 1/2 ACRE IN AREA for each family. The permit to the use of these waters is issued under Application 69229 with a date of priority of AUGUST 11, 1987. The permit is limited to not more than 0.04 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The use is further defined as:

0.02 cfs from unnamed streams 1 and 2 and reservoir (POD 1) for domestic use for three families (house sites 1, 2 and 3) including the irrigation of lawns and gardens not to exceed one-half acre in area for each family;

0.01 cfs from unnamed stream 4 (POD 3) supplemented by use from unnamed stream 6 (POD 5) for domestic use for one family (house site 4) including the irrigation of a lawn and garden not to exceed one-half acre in area;

0.01 cfs from unnamed stream 3 (POD 4) supplemented by use from unnamed stream 5 (POD 2) for domestic use for one family (house site 5) including the irrigation of a lawn and garden not to exceed one-half acre in area.

The points of diversion are located as follows:

- POD (1) SE 1/4 SE 1/4, Section 1, T 25 S, R 13 W, WM; 1100 FEET NORTH & 1350 FEET WEST FROM SE CORNER, SECTION 1.
- POD (2) SW 1/4 SE 1/4, Section 1, T 25 S, R 13 W,WM; 700 FEET NORTH & 2700 FEET WEST FROM SE CORNER, SECTION 1.
- POD (3) SW 1/4 SE 1/4, Section 1, T 25 S, R 13 W, WM; 800 FEET NORTH & 2100 FEET WEST FROM SE CORNER, SECTION 1.
- POD (4) SW 1/4 SE 1/4, Section 1, T 25 S, R 13 W, WM; 400 FEET NORTH & 3300 FEET WEST FROM SE CORNER, SECTION 1.
- POD (5) SW 1/4 SE 1/4, Section 1, T 25 S, R 13 W, WM; 600 FEET NORTH & 1800 FEET WEST FROM SE CORNER, SECTION 1.

The use of water allowed under this permit shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the permit is as follows:

Actual construction work shall begin on or before SEPTEMBER 26, 1990, and shall be completed on or before October 1, 1991. Complete application of the water to the use shall be made on or before October 1, 1992.

This permit is for the beneficial use of water without waste. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
