to use the waters of NORTH UMPQUA RIVER, a tributary of UMPQUA RIVER, for DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 2.1 ACRES.

This Permit is issued approving Application 69593. The date of priority is APRIL 14, 1988. The use is limited to not more than 0.031 CUBIC FOOT PER SECOND, BEING 0.005 CFS FOR DOMESTIC AND 0.026 CFS FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NW 1/4, SECTION 23, T 26 S, R 6 W, W.M.; 1200 FEET SOUTH AND 900 FEET EAST FROM NW CORNER, SECTION 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the Permit is as follows:

NW 1/4 NW 1/4 0.9 ACRE

SW 1/4 NW 1/4 1.1 ACRES AND DOMESTIC

SE 1/4 NW 1/4 0.1 ACRE

SECTION 23

TOWNSHIP 26 SOUTH, RANGE 6 WEST, W.M.

Actual construction work shall begin on or before SEPTEMBER 29, 1990, and shall be completed on or before October 1, 1991. Complete application of the water to the use shall be made on or before October 1, 1992.

This permit is for the beneficial use of water without waste. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
