PERMIT TO APPROPRIATE THE PUBLIC WATERS

to use the waters of DAIRY CREEK, a tributary of TUALATIN RIVER, for IRRIGATION OF 31.7 ACRES.

This Permit is issued approving Application 69609. The date of priority is MAY 17, 1988. The use is limited to not more than 0.396 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NW 1/4, SECTION 1, T 1 S, R 3 W, W.M.; SOUTH 64 DEGREES 45 MINUTES EAST, 525 FEET FROM SW CORNER, NW 1/4 NW 1/4, SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further water shall not be appropriated during the period from July 31 through September 15 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the Permit is as follows:

NE 1/4 NE 1/4	3.72 ACRES
NW 1/4 NE 1/4	10.36 ACRES
NW 1/4 SE 1/4	9.10 ACRES
SW 1/4 SE 1/4	8.52 ACRES

SECTION 2

TOWNSHIP 1 SOUTH, RANGE 3 WEST, W.M.

Actual construction work shall begin on or before SEPTEMBER 29, 1990, and shall be completed on or before October 1, 1991. Complete application of the water to the use shall be made on or before October 1, 1992.

This permit is for the beneficial use of water without waste. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
