PERMIT TO APPROPRIATE THE PUBLIC WATERS

to use the waters of AN UNNAMED STREAM AND RESERVOIR constructed under Permit R-8104, and McVAY CREEK, tributaries of PACIFIC OCEAN, for IRRIGATION OF 3.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 45.6 ACRES.

This Permit is issued approving Application 69197. The date of priority is JULY 20, 1987 FOR USE FROM McVAY CREEK AND DECEMBER 7, 1987 FOR USE FROM STREAM AND RESERVOIR. The use is limited to not more than 0.61 CUBIC FOOT PER SECOND, being 0.57 cfs from McVay Creek for supplemental irrigation and 0.04 cfs from unnamed stream and reservoir, supplemented by use from McVay Creek, for irrigation, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

McVAY CREEK: SW 1/4 SW 1/4, SECTION 14, T 41 S, R 13 W, W.M.; 1280 FEET NORTH AND 40 FEET EAST FROM SW CORNER, SECTION 14.

STREAM/RESERVOIR: SE 1/4 SW 1/4, SECTION 15, T 41 S, R 13 W, W.M.; 550 FEET SOUTH AND 190 FEET WEST FROM CS 1/16 CORNER, SECTION 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the Permit is as follows:

TOWNSHIP 41 SOUTH, RANGE 13 WEST, W.M.

Actual construction work shall begin on or before JANUARY 17, 1991, and shall be completed on or before October 1, 1991. Complete application of the water to the use shall be made on or before October 1, 1992.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
