to use the waters of GUY CREEK, RICKREALL CREEK, AND MANNENBACH RESERVOIR, to be constructed under Application R-70085, Permit R-11194, tributaries of WILLAMETTE RIVER, FOR FISH AND WILDLIFE.

This Permit is issued approving Application 70086. The date of priority is OCTOBER 2, 1989. The use is limited to not more than 0.01 CUBIC FOOT PER SECOND FROM GUY CREEK, WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY TO BE MADE UP BY PUMPING FROM RICKREALL CREEK AT THE RATE OF 0.18 CFS FOR NO MORE THAN EIGHT HOURS EACH WEEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NE 1/4, SECTION 31, T 7 S, R 5 W, W.M.; GUY CREEK - 860 FEET NORTH AND 1260 FEET WEST; RICKREALL CREEK - 870 FEET NORTH AND 1550 FEET WEST, BOTH FROM NW CORNER DLC 51.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the Permit is as follows:

NW 1/4 NE 1/4 SECTION 31 TOWNSHIP 7 SOUTH, RANGE 5 WEST, W.M.

Actual construction work shall begin on or before JANUARY 17, 1991, and shall be completed on or before October 1, 1991. Complete application of the water to the use shall be made on or before October 1, 1992.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
