to use the waters of COW CREEK AND GALESVILLE RESERVOIR, constructed under for ROAD WATERING-Permit R-9964, tributaries of SOUTH UMPQUA RIVER, MAINTENANCE AND INDUSTRIAL USE.

This Permit is issued approving Application 69481. The date of priority is NOVEMBER 24, 1987. The use is limited to not more than 1.1 CUBIC FEET PER SECOND AND 205.0 ACRE-FEET STORED WATER ONLY, being 0.1 CFS and 5.0 AF for road watering and 1.0 CFS and 200.0 AF for industrial, or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

SW 1/4 NE 1/4, SECTION 28, T 31 S, R 4 W, W.M.; 2920 GALESVILLE RESERVOIR FEET NORTH AND 2060 FEET WEST FROM SE CORNER, SECTION 28.

Water shall not be appropriated from direct flow during the period from July 15 to September 30 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
