to use the waters of HUTCHCROFT CREEK, a tributary of NORTH YAMHILL RIVER, for DOMESTIC USE FOR SEVEN FAMILIES AND IRRIGATION OF 9.8 ACRES.

This Permit is issued approving Application 70082. The date of priority is SEPTEMBER 29, 1989. The use is limited to not more than 0.13 CUBIC FOOT PER SECOND, being 0.01 CFS for domestic and 0.12 CFS for irrigation, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 35, T 2 S, R 5 W, W.M.; 1660 FEET NORTH AND 530 FEET WEST FROM SE CORNER, SECTION 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the Permit is as follows:

Actual construction work shall begin on or before APRIL 5, 1991, and shall be completed on or before October 1, 1992. Complete application of the water to the use shall be made on or before October 1, 1993.
