THIS PERMIT IS HEREBY ISSUED TO

to use the waters of TWO UNNAMED CREEKS, tributaries of ALSEA RIVER, for DOMESTIC USE FOR TEN (10) FAMILIES INCLUDING IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NONCOMMERCIAL GARDEN EACH, SUPPLEMENTAL DOMESTIC USE FOR NUME (9) FAMILIES, AND IRRIGATION OF 5.0 ACRES.

This Permit is issued approving Application 56494. The date of priority is AUGUST 25, 1977 FOR 0.0095 CFS FROM EACH CREEK AND FEBRUARY 24, 1988 FOR 0.0355 CFS FROM WEST CREEK AND 0.0455 CFS FROM EAST CREEK. The use is limited to not more than 0.1 CUBIC FOOT PER SECOND, BEING 0.015 CFS FROM EACH CREEK FOR DOMESTIC INCLUDING LAWNS & GARDENS FOR 10 FAMILIES; 0.01 CFS FROM EAST CREEK FOR SUPPLEMENTAL DOMESTIC FOR 9 FAMILIES; AND 0.03 CFS FROM EACH CREEK FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the sources.

The points of diversion are located as follows:

LOT 3, SECTION 27, T 13 S, R 10 W, W.M.; WEST CREEK - 2259.5 FEET NORTH AND 2484.0 FEET WEST; EAST CREEK - 2274.5 FEET NORTH AND 2054.0 FEET WEST BOTH FROM SE CORNER, SECTION 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

LOT 2 (NE 1/4 SE 1/4 0.3 ACRE & DOMESTIC LOT 3 (NW 1/4 SE 1/4) 4.7 ACRES & DOMESTIC SECTION 27

TOWNSHIP 13 SOUTH, RANGE 10 WEST, W.M.

NOTE: The place of use for domestic use for ten families including lawns and gardens is further described as being on Trollers Cove Subdivision Lots 2, 3, 4, 10, 12, 15, 16, 17, 18 and 19.

The place of use for supplemental domestic use for nine families and irrigation of 5.0 acres is further described as being on Trollers Cove Subdivision Lots 1, 5, 6, 7, 8, 9, 11, 12 and 14.

Actual construction work shall begin on or before APRIL 30, 1991, and shall be completed on or before October 1, 1992. Complete application of the water to the use shall be made on or before October 1, 1993.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
