THIS PERMIT IS HEREBY ISSUED TO

to use the waters of CHRISTENSEN CREEK and KOEHNKE RESERVOIR, constructed under Permit R-4663, and enlarged under Application R-69995, Permit R-1222, tributaries of TUALATIN RIVER, for IRRIGATION OF 76.3 ACRES.

This Permit is issued approving Application 69996. The date of priority is JULY 13, 1989. The use is limited to not more than 88.3 ACRE-FEET of STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 HW 1/4, SECTION 34, T 1 S, R 3 W, W.M.; 1060 FEET SOUTH AND 990 FEET WEST FROM N 1/4 CORNER, SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

Diversion screening or fish passage facilities shall be designed, installed and operated to Oregon Department of Fish and Wildlife specifications.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the Permit is as follows:

NW 1/4 SW 1/4 0.9 ACRE SW 1/4 SW 1/4 17.0 ACRE SECTION 27

NE 1/4 SE 1/4 2.8 ACRES SE 1/4 SE 1/4 9.2 ACRES SECTION 28

NE 1/4 NE 1/4 17.7 ACRES SE 1/4 NE 1/4 0.7 ACRE SECTION 33

NW 1/4 NW 1 /4 26.9 ACRES SW 1 /4 NW 1/4 1.1 ACRES SECTION 34 TOWNSHIP 1 SOUTH, RANGE 3 WEST, W.M.

This project was considered and approved by the Water Resources Commission on March 30, 1990.

Actual construction work shall begin on or before APRIL 30, 1991, and shall be completed on or before October 1, 1992. Complete application of the water to the use shall be made on or before October 1, 1993.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
