PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to use the waters of AN UNNAMED STREAM AND WILLIAMSON RESERVOIR, to be constructed under Application R-69168, Permit R-11224, a tributary of TUALATIN RIVER, for IRRIGATION OF 49.9 ACRES AND SUPPLEMENTAL IRRIGATION OF 50.6 ACRES.

This Permit is issued approving Application 69169. The date of priority is JUNE 29, 1987. The use is limited to not more than 0.62 CUBIC FOOT PER SECOND and NOT TO EXCEED 38.0 ACRE-FEET ANNUALLY FROM WILLIAMSON RESERVOIR, BEING 0.62 CFS FROM STREAM SUPPLEMENTED BY STORED WATER FROM THE RESERVOIR FOR IRRIGATION OF 49.9 ACRES AND STORED WATER FROM THE RESERVOIR FOR SUPPLEMENTAL IRRIGATION OF 50.6 ACRES, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, SECTION 22, T 1 S, R 2 W, W.M.; 260 FEET NORTH AND 660 FEET EAST FROM SW CORNER, SECTION 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The permit shall be limited to any deficiency in the available supply of any prior permit for the same land and shall not exceed the limitation allowed herein.

Water shall not be appropriated from direct flow during the period from June 30 through September 30 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the Permit is as follows:

This project was considered and approved by the Water Resources Commission on May 11, 1990.

Actual construction work shall begin on or before MAY 18, 1991, and shall be completed on or before October 1, 1992. Complete application of the water to the use shall be made on or before October 1, 1993.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
