to use the waters of NYSSA-ARCADIA DRAINAGE DISTRICT MAIN DRAIN, a tributary of SNAKE RIVER, for IRRIGATION OF 148.5 ACRES.

This Permit is issued approving Application 69812. The date of priority is JANUARY 26, 1989. The use is limited to not more than 3.71 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SE 1/4, SECTION 8, T 19 S, R 47 E, W.M.; 45 FEET NORTH AND 3100 FEET EAST FROM SW CORNER, SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of an agreement between Nyssa-Arcadia Drainage District and the applicant recorded in the Miscellaneous Records of the Water Resources Director at Volume 7, page 2328, and by reference made a part hereof.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:
