PERMIT TO APPROPRIATE THE PUBLIC WATERS

to use the waters of A SPRING, a tributary of UMPQUA RIVER, for DOMESTIC USE FOR ONE FAMILY INCLUDING IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NONCOMMERCIAL GARDEN, AND UMPQUA RIVER, a tributary of PACIFIC OCEAN, for RELATED NURSERY USES ON 10.0 ACRES AND LIVESTOCK.

This Permit is issued approving Application 70156. The date of priority is DECEMBER 28, 1989. The use is limited to not more than 0.14 CUBIC FOOT PER SECOND, BEING 0.01 CFS FOR DOMESTIC FROM SPRING, 0.125 CFS FOR NURSERY AND 0.005 CFS FOR LIVESTOCK FROM RIVER, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 NW 1/4, SECTION 7, T 25 S, R 7 W, W.M.; SPRING - 500 FEET NORTH AND 40 FEET EAST FROM W 1/4 CORNER, SECTION 7.

NE 1/4 SE 1/4, SECTION 12, T 25 S, R 8 W, W.M.; RIVER - 290 FEET SOUTH AND 400 FEET WEST FROM W 1/4 CORNER, SECTION 7, T 25 S, R 7 W, W.M.

The amount of water used for Nursery Operations (OAR 690-11-010(14)) is limited to a diversion of 0.15 cubic foot per second per acre. For the irrigation of **containerized nursery plants**, the amount of water diverted is limited to ONE-FORTIETH of one cubic foot per second (or its equivalent) and 5.0 acre feet per acre per year. For the irrigation of **in-ground nursery plants** the amount of water diverted is limited to ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre feet per acre per year. The use of water for NURSERY OPERATIONS may be at any time of the year that the use is beneficial. For the irrigation of **any other crop**, the amount of water diverted is limited to ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre feet per acre during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the Permit is as follows:

SW 1/4 NW 1/4 0.1 ACRE  
NW 1/4 SW 1/4 1.8 ACRES & LIVESTOCK  
SECTION 7  
TOWNSHIP 25 SOUTH, RANGE 7 WEST, W.M.

SE 1/4 NE 1/4 5.8 ACRES & DOMESTIC  
NE 1/4 SE 1/4 2.3 ACRES & LIVESTOCK  
SECTION 12  
TOWNSHIP 25 SOUTH, RANGE 8 WEST, W.M.

Actual construction work shall begin on or before JULY 27, 1991, and shall be completed on or before October 1, 1992. Complete application of the water to the use shall be made on or before October 1, 1993.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use granted herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
