APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, School District No. 27, blaine, County of Tillamook, State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed stream (Name of stream)

tributary of Moore Creek (Nestucca R.)

2. The amount of water which the applicant intends to apply to beneficial use is 0.25 cubic feet per second.

3. The use to which the water is to be applied is Domestic supplies (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located S 30 1/2 ° E. 26.56 chains from the 1/4 section corner on the west line of section Township 3 South of range 8 West W.M.Ore. (Give distance and bearing to section corner)

5. The main pipe line to be 18.50 chains (Main ditch, canal or pipe line) miles in length, terminating in the NW 1/4 of the SW 1/4 of Sec. 29, Tp. 3 S, R. 8 W, W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (No. N. or S.) (No. E. or W.)

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from an unnamed stream for irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.1 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is June 15, 1921

Actual construction work shall begin on or before July 5, 1922 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1923

Complete application of the water to the proposed use shall be made on or before October 1, 1924
