to use the waters of AN UNNAMED STREAM, a tributary of SUMMER CREEK, for MAINTAINING MURRAYHILL RESERVOIR, to be constructed under Application R-68977, Permit R-11252, FOR AESTHETICS.

This Permit is issued approving Application 70245. The date of priority is MARCH 21, 1990. The use is limited to the period from September 16 to July 30 of each year and not more than 0.3 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 32, T 1 S, R 1 W, W.M.; 200 FEET SOUTH AND 65 FEET WEST FROM E 1/4 CORNER, SECTION 32.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

> SE 1/4 NE 1/4 NE 1/4 SE 1/4 SECTION 32 TOWNSHIP 1 SOUTH, RANGE 1 WEST, W.M.

When in the judgment of the watermaster it becomes necessary to regulate waters of the stream system, use of water shall be subject to the installation of suitable devices for measuring flows diverted into the reservoir from the unnamed stream, incoming natural flows of Summer Creek basin into the reservoir and outflows from the reservoir. types and plans for such devices shall be approved by the watermaster and shall be installed under the general supervision of watermaster.

Actual construction work shall begin on or before OCTOBER 1, 1991, and shall be completed on or before October 1, 1992. Complete application of the water to the use shall be made on or before October 1, 1993.
