## PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

OTAK, INC. for GSL PROPERTIES LAKE OSWEGO, OREGON 97034

**503-635**-3618

to use the waters of AN UNNAMED STREAM, a tributary of FANNO CREEK, to maintain RESERVOIRS A, B, C, AND WETLAND MITIGATION AREA, to be constructed under Application R-68976, Permit R-11251, for AESTHETICS AND WILDLIFE.

This Permit is issued approving Application 70259. The date of priority is MARCH 26, 1990. THE USE IS LIMITED TO THE PERIOD FROM SEPTEMBER 16 TO JULY 30 EACH YEAR and not more than 0.11 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SW 1/4, SECTION 33, T 1 S, R 1 W, W.M.; RESERVOIR A - 297 FEET SOUTH AND 608 FEET EAST; RESERVOIR B - 255 FEET SOUTH AND 512 EAST; RESERVOIR C - 267 FEET SOUTH AND 340 FEET EAST; WETLAND MITIGATION AREA - 382 FEET SOUTH AND 720 FEET EAST, ALL FROM W 1/4 CORNER, SECTION 33.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

NW 1/4 SW 1/4
SECTION 33
TOWNSHIP 1 SOUTH, RANGE 1 WEST, W.M.

When in the judgment of the watermaster it becomes necessary to regulate waters of the stream system, use of water shall be subject to the installation of suitable devices for measuring flows diverted into the reservoir from unnamed stream, incoming natural flows of Fanno Creek basin into the reservoir and outflows from the reservoir. The types and plans for such devices shall be approved by the watermaster and shall be installed under the general supervision of said watermaster.

Actual construction work shall begin on or before OCTOBER 1, 1991, and shall be completed on or before October 1, 1992. Complete application of the water to the use shall be made on or before October 1, 1993.
