to use the waters of AN UNNAMED STREAM, a tributary of WILLAMETTE RIVER, for IRRIGATION OF 1.7 ACRES.

This Permit is issued approving Application 70299. The date of priority is APRIL 19, 1990. The use is limited to not more than 0.01 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SW 1/4, SECTION 23, T 3 S, R 1 W, W.M.; 170 FEET NORTH AND 1855 FEET WEST FROM NE CORNER, DLC 42.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

NE 1/4 SW 1/4 0.1 ACRE SE 1/4 SW 1/4 1.6 ACRES SECTION 23 TOWNSHIP 3 SOUTH, RANGE 1 WEST, W.M.

Actual construction work shall begin on or before OCTOBER 15, 1991, and shall be completed on or before October 1, 1992. Complete application of the water to the use shall be made on or before October 1, 1993.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
