## PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to use the waters of NORTH SANTIAM RIVER AND DETROIT RESERVOIR, constructed under Permit R-1625, tributaries of SANTIAM RIVER, for IRRIGATION OF 2.25 ACRES.

This Permit is issued approving Application 70616. The date of priority is SEPTEMBER 4, 1990. The use is limited to not more than 0.028 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

RIVER - NE 1/4 NE 1/4, SECTION 20, T 9 S, R 2 E, W.M.; 1376 FEET NORTH

AND 462 FEET WEST FROM E 1/4 CORNER, SECTION 20.

DETROIT RESERVOIR - SW 1/4 NW 1/4, SECTION 7, T 10 S, R 5 E, W.M.

Diversion screening or fish passage facilities shall be designed, installed, and operated to Oregon Department of Fish & Wildlife specifications.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

NE 1/4 NE 1/4 0.32 ACRE SE 1/4 NE 1/4 1.93 ACRES SECTION 20 TOWNSHIP 9 SOUTH, RANGE 2 EAST, W.M.

The use of water under this permit is subject to the terms and conditions of Contract 1-07-10-W0818 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.

Actual construction work shall begin on or before January 14, 1992, and shall be completed on or before October 1, 1992. Complete application of the water to the use shall be made on or before October 1, 1993.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the permit.
