to use the waters of LOST CREEK RESERVOIR CONSTRUCTED UNDER PERMIT R-8142, a tributary of PACIFIC OCEAN, for IRRIGATION OF 147.3 ACRES.

This Permit is issued approving Application 70741. The date of priority is OCTOBER 11, 1990. The use is limited to not more than 220.95 ACRE FEET OF STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

RIVER - LOT 8 (NW 1/4 NW 1/4), SECTION 29, T 35 S, R 1 W, W.M.; 10 FEET SOUTH AND 800 FEET EAST FROM NW CORNER, SECTION 29.

LOST CREEK RESERVOIR - NW 1/4, SECTION 26, T 33 S, R 1 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The water user shall comply with the terms and conditions of Contract 1-07-10-W0826 dated January 17, 1991, between BUREAU OF RECLAMATION and BRUCE L. CARPENTER. A copy of the contract is in Application File # 70741 at the Water Resources Department.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

Actual construction work shall begin on or before January 28, 1992, and shall be completed on or before October 1, 1992. Complete application of the water to the use shall be made on or before October 1, 1993. The use of water under this permit is subject to the terms and conditions of Contract between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.
