to use the waters of SCOTT CREEK AND 13 SPRINGS, a tributaries of UMPQUA RIVER, for IRRIGATION OF 2.0 ACRES, DOMESTIC USE FOR ONE FAMILY, DOMESTIC USE EXPANDED FOR ONE FAMILY, AND LIVESTOCK.

This permit is issued approving Application 70044. The date of priority is AUGUST 24, 1989. The use is limited to not more than 0.11 CUBIC FOOT PER SECOND (CFS), BEING 0.025 CFS FROM SCOTT CREEK FOR IRRIGATION, 0,005 CFS FROM SPRING 2 FOR DOMESTIC USE, 0.01 CFS FROM SPRING 13 FOR DOMESTIC USE EXPANDED AND 0.005 CFS FROM SPRINGS 3 THROUGH 9 AND 11 THROUGH 13, AND 0.01 CFS FROM SPRINGS 10 AND 11 FOR LIVESTOCK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SCOTT CREEK - NW 1/4 SW 1/4, SECTION 1, 300 FEET SOUTH AND 180 FEET EAST FROM W 1/4 CORNER SECTION 1;

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
