## PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to use the waters of SOUTH SANTIAM RIVER, a tributary of SANTIAM RIVER, for IRRIGATION OF 10.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 22.8 ACRES.

This Permit is issued approving Application 70974. The date of priority is DECEMBER 6, 1990 FOR 0.40 CUBIC FOOT PER SECOND (CFS), AND DECEMBER 14, 1990 FOR 0.02 CFS. The use is limited to not more than 0.42 CFS, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 29, T 10 S, R 2 W, W.M.; 1050 FEET SOUTH AND 920 FEET WEST FROM NE CORNER, SECTION 29.

Diversion screening or fish passage facilities shall be designed, installed, and operated to Oregon Department of Fish & Wildlife specifications.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
