## PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

McKENZIE RIVER GOLF COURSE, INC. P.O. BOX 98 WALTERVILLE, OREGON 97489

to use the waters of HAUGEN CREEK, a tributary of McKENZIE RIVER, for IRRIGATION OF 58.8 ACRES.

This Permit is issued approving Application 70274. The date of priority is APRIL 3, 1990. The use is limited to not more than 0.724 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SW 1/4, SECTION 17, T 17 S, R 1 E, W.M.; 1540 FEET NORTH AND 1245 FEET EAST FROM SW CORNER, SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
