to use the waters of A RESERVOIR, to be constructed under Application R-70455, Permit R-11374, tributary of NORTH FORK CROOKED RIVER, for SUPPLEMENTAL IRRIGATION OF 410.0 ACRES.

This Permit is issued approving Application 70456. The date of priority is JULY 2, 1990 FOR 340 ACRE-FEET (AF), MAY 14, 1991 FOR 60 AF AND MAY 15, 1991 FOR 30.0 AF. The use is limited to not more than 430.0 AF STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

DAM LOCATED: NE 1/4 NW 1/4, Section 6, T 14 S, R 21 E, W.M.; 2870 feet South and 2380 feet East from W 1/4 Corner, Section 31, T 13 S, R 21 E, W.M.

Diversion screening or fish passage facilities on the Indian Creek diversion shall be designed, installed, and operated to Oregon Department of Fish & Wildlife specifications. No screening for fish passage will be required on Shady Creek.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This development was reviewed and approved by the Water Resources Commission on May 31, 1991.

Actual construction work shall begin on or before June 3, 1992, and shall be completed on or before October 1, 1993. Complete application of the water to the use shall be made on or before October 1, 1994.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
