PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to use the waters of BURNT RIVER AND GALE CREEK, tributaries of SNAKE RIVER, for IRRIGATION OF 4.0 ACRES AND DOMESTIC USE FOR ONE FAMILY INCLUDING IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND GARDEN.

This Permit is issued approving Application 70294. The date of priority is APRIL 16, 1990. The use is limited to not more than 0.11 CUBIC FOOT PER SECOND, BEING 0.1 CFS FOR IRRIGATION FROM BURNT RIVER AND 0.01 CFS FOR DOMESTIC USE FROM GALE CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 SW 1/4, SECTION 18, T 12 S, R 44 E, W.M.; SE 1/4 SE 1/4, SECTION 13; NW 1/4 NE 1/4, SECTION 24, T 12 S, R 43 E, W.M.; BURNT RIVER - 1254 FEET NORTH AND 422 FEET EAST; GALE CREEK - 730 FEET NORTH AND 170 FEET WEST; BOTH FROM SW CORNER, SECTION 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

NW 1/4 SW 1/4 0.4 ACRE
SW 1/4 SW 1/4 3.6 ACRES AND DOMESTIC
SECTION 18
TOWNSHIP 12 SOUTH, RANGE 44 EAST, W.M.

Actual construction work shall begin on or before July 1, 1992, and shall be completed on or before October 1, 1993. Complete application of the water to the use shall be made on or before October 1, 1994.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the permit.
