THIS PERMIT IS HEREBY ISSUED TO

to use the waters of ALBANY CHANNEL WILLAMETTE RIVER AND WILLAMETTE BASIN PROJECT RESERVOIRS, a tributary of COLUMBIA RIVER, for IRRIGATION OF 197.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 187.1 ACRES.

This permit is issued approving Application 71608. The date of priority is MAY 20, 1991. The use is limited to not more than 4.8 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source. No water may be appropriated from direct flow during the period July 1 through August 31.

The point of diversion is located as follows:

NW 1/4 NW 1/4, SECTION 18, T 13 S, R 4 W, W.M.; 70 FEET SOUTH AND 150 FEET EAST FROM NW CORNER, SECTION 18.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The water user shall comply with the terms and conditions of contract dated 17th day of July, 1991, between Bureau of Reclamation and Torri L. Schrock. A copy of the contract is in Application File # 71608 at the Water Resources Department.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
