PERMIT TO APPROPRIATE THE PUBLIC WATERS

to use the waters of THREE SPRINGS, a tributary of BRYAN CREEK, for IRRIGATION OF 19.7 ACRES AND DOMESTIC USE FOR ONE FAMILY INCLUDING THE IRRIGATION OF LAWN AND NON-COMMERCIAL GARDEN NOT TO EXCEED ONE-HALF ACRE.

This permit is issued approving Application 71115. The date of priority is JANUARY 7, 1991. The use is limited to not more than 0.257 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FROM SPRING A FOR DOMESTIC USE; 0.11 CFS FROM SPRING A WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY TO BE APPROPRIATED FROM SPRING B FOR IRRIGATION OF 8.8 ACRES; 0.073 CFS FROM SPRING A WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM SPRING C FOR IRRIGATION OF 5.8 ACRES; 0.025 CFS FROM SPRING B FOR IRRIGATION OF 2.0 ACRES AND 0.039 CFS FROM SPRING C FOR IRRIGATION OF 3.1 ACRES, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 NW 1/4, SE 1/4 NW 1/4, SECTION 36, T 2 S, R 3 W, W.M.;
SPRING A - 1090 FEET NORTH AND 890 FEET EAST, SPRING B - 940 FEET NORTH AND 1440 FEET EAST, SPRING C - 910 FEET NORTH AND 240 FEET EAST ALL FROM W 1/4 CORNER, SECTION 36.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

SPRING A

SW 1/4 NW 1/4 DOMESTIC

SPRING A with any deficiency in the supply from Spring C

SW 1/4 NW 1/4 5.8 ACRES

SPRING A with any deficiency in the supply from Spring B

SW 1/4 NW 1/4 7.8 ACRES

SE 1/4 NW 1/4 1.0 ACRE

SPRING B

SE 1/4 NW 1/4 2.0 ACRES

SPRING C

SW 1/4 NW 1/4 3.1 ACRES

SECTION 36

TOWNSHIP 2 SOUTH, RANGE 3 WEST, W.M.

Actual construction work shall begin on or before October 14, 1992, and shall be completed on or before October 1, 1993. Complete application of the water to the use shall be made on or before October 1, 1994.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
