to use the waters of NORTH UMPQUA RIVER, a tributary of UMPQUA RIVER, for IRRIGATION OF 0.92 ACRE AND DOMESTIC USE FOR ONE FAMILY.

This Permit is issued approving Application 70445. The date of priority is JUNE 27, 1990. The use is limited to not more than 0.015 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FOR IRRIGATION AND 0.005 CFS FOR DOMESTIC, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SW 1/4, SECTION 27, T 26 S, R 6 W, W.M.; 1130 FEET NORTH AND 210 FEET WEST FROM S 1/4 CORNER, SECTION 27.

Diversion screening or fish passage facilities shall be designed, installed, and operated to Oregon Department of Fish & Wildlife specifications.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

> SE 1/4 SW 1/4 0.34 ACRE & DOMESTIC SW 1/4 SE 1/4 0.58 ACRE SECTION 27 TOWNSHIP 26 SOUTH, RANGE 6 WEST, W.M.

Actual construction work shall begin on or before October 28, 1992, and shall be completed on or before October 1, 1993. Complete application of the water to the use shall be made on or before October 1, 1994.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the permit.
