PERMIT TO APPROPRIATE THE PUBLIC WATERS

THIS PERMIT IS HEREBY ISSUED TO

to use the waters of EVANS CREEK, a tributary of NORTH FORK COQUILLE RIVER, for DOMESTIC USE FOR FOUR FAMILIES INCLUDING IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NONCOMMERCIAL GARDEN EACH.

This Permit is issued approving Application 70539. The date of priority is AUGUST 6, 1990. The use is limited to not more than 0.008 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SE 1/4, SECTION 14, T 27 S, R 12 W, W.M.; 644 FEET SOUTH AND 776 FEET EAST; 881 FEET SOUTH AND 1010 FEET EAST, BOTH FROM C 1/4 CORNER, SECTION 14.

Diversion screening or fish passage facilities shall be designed, installed, and operated to Oregon Department of Fish & Wildlife specifications.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this Permit is as follows:

NW 1/4 SE 1/4
SECTION 14
TOWNSHIP 27 SOUTH, RANGE 12 WEST, W.M.

Actual construction work shall begin on or before November 18, 1992, and shall be completed on or before October 1, 1993. Complete application of the water to the use shall be made on or before October 1, 1994.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
