to use the waters of THREE UNNAMED STREAMS AND AN UNNAMED RESERVOIR CONSTRUCTED UNDER APPLICATION R-71723, PERMIT R-11416, tributaries of CATCHING SLOUGH, for DOMESTIC USE FOR ONE FAMILY, IRRIGATION OF 0.46 ACRE AND AESTHETICS.

This permit is issued approving Application 71724. The date of priority is JUNE 27, 1991. The use is limited to not more than 0.035 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FROM UNNAMED STREAM #1 FOR DOMESTIC USE; 0.01 CFS FROM UNNAMED STREAMS 1, 2, 3 & RESERVOIR FOR IRRIGATION; AND 0.015 CFS FROM UNNAMED STREAMS 1, 2 & 3 FOR RESERVOIR MAINTENANCE (AESTHETICS) or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SE 1/4, SECTION 6, T 26 S, R 12 W, W.M.; UNNAMED STREAM 1 - 515.1 FEET NORTH AND 1072.3 FEET WEST, UNNAMED STREAM 2 - 583.5 FEET NORTH AND 884.4 FEET WEST, BOTH FROM SE CORNER, SECTION 6.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

SE 1/4 SE 1/4 0.46 ACRE & DOMESTIC
SECTION 6
TOWNSHIP 26 SOUTH, RANGE 12 WEST, W.M.

Actual construction work shall begin on or before November 18, 1992, and shall be completed on or before October 1, 1993. Complete application of the water to the use shall be made on or before October 1, 1994.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.
