to use the waters of COE CREEK, a tributary of MIDDLE FORK HOOD RIVER, for SUPPLEMENTAL IRRIGATION OF 6012.0 ACRES TEMPERATURE CONTROL, MAINTENANCE OF A FIRE PROTECTION SYSTEM AND STOCK WATER.

This permit is issued approving Application 68490. The date of priority is AUGUST 19, 1985. The use is limited to not more than 30.0 CUBIC FEET PER SECOND (CFS), BEING 29.5 CFS FOR SUPPLEMENTAL IRRIGATION, 0.25 CFS FOR MAINTENANCE OF A FIRE PROTECTION SYSTEM, 0.25 CFS FOR STOCK WATER AND 10.0 CFS FOR NON-IRRIGATION SEASON TEMPERATURE CONTROL, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4, SECTION 26, T 1 S, R 9 E, W.M.; 2598.92 FEET SOUTH AND 945.01 FEET WEST FROM NE CORNER, SECTION 27.

The amount of water diverted for irrigation and temperature control with the amounts secured under any other rights existing for the same lands, is limited as follows: For temperature control, 0.15 cubic foot per second per acre; For irrigation ONE-EIGHTIETH of one cubic foot per second and 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

STOCK WATER, MAINTENANCE OF A FIRE PROTECTION SYSTEM AND NON-IRRIGATION SEASON TEMPERATURE CONTROL ON ANY LANDS WITHIN THE BOUNDARIES OF THE DISTRICT AND SUPPLEMENTAL IRRIGATION FOR;

TOWNSHIP 1 NORTH, RANGE 10 EAST W.M.

This development was reviewed and approved by the Water Resources Commission on May 13, 1988.

Actual construction work shall begin on or before November 18, 1992, and shall be completed on or before October 1, 1993. Complete application of the water to the use shall be made on or before October 1, 1994.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
