to use the waters of AN UNNAMED INTERMITTENT STREAM, a tributary of STARR CREEK, for MAINTAINING RESERVOIR CONSTRUCTED UNDER APPLICATION R-71778, PERMIT R-11463 FOR WILDLIFE HABITAT.

This permit is issued approving Application 71779. The date of priority is JULY 25, 1991. The use is limited to not more than 1.0 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source. Water may only be appropriated from November 1 through March 31 of each year.

The points of diversion are located as follows:

NE 1/4 NE 1/4, SECTION 11, NW 1/4 SW 1/4, SW 1/4 SW 1/4, SECTION 12, T 13 S, R 6 W, W.M.; DIVERSION POINT 1 - 120 FEET SOUTH AND 880 FEET WEST; DIVERSION POINT 2 - 300 FEET SOUTH AND 800 FEET WEST; DIVERSION POINT 3 - 650 FEET SOUTH AND 560 FEET WEST; DIVERSION PONT 4 - 800 FEET SOUTH AND 300 FEET WEST; DIVERSION POINT 5 - 1150 FEET SOUTH AND 40 FEET EAST; DIVERSION POINT 6 - 1420 FEET SOUTH AND 400 FEET EAST, ALL FROM SE CORNER, DLC 43.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under this permit is as follows:

SECTION 11
NW 1/4 SW 1/4
SW 1/4 SW 1/4
SECTION 12
TOWNSHIP 13 SOUTH, RANGE 6 WEST, W.M.

Actual construction work shall begin on or before July 6, 1993, and shall be completed on or before October 1, 1994. Complete application of the water to the use shall be made on or before October 1, 1995.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.
