to use the waters of LITTLE RIVER AND GREENMAN CREEK, tributaries of NORTH UMPQUA RIVER, for the purpose of IRRIGATION OF 4.8 ACRES AND DOMESTIC USE FOR ONE FAMILY.

This Permit is issued approving Application 69908. The date of priority is MAY 16, 1989. The use is limited to not more than 0.065 CUBIC FOOT PER SECOND, BEING 0.05 CFS FROM LITTLE RIVER FOR IRRIGATION OF 4.0 ACRES AND 0.01 CFS FOR SUPPLEMENTAL IRRIGATION OF 0.8 ACRE AND 0.005 CFS FOR SUPPLEMENTAL DOMESTIC USE FROM GREENMAN CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SW 1/4, SE 1/4 NW 1/4, SECTION 8, T 27 S, R 2 W, W.M.; RIVER - 800 FEET SOUTH AND 230 FEET WEST; CREEK - 1220 FEET NORTH AND 120 FEET WEST, BOTH FROM C 1/4 CORNER, SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right shall be limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the proposed place of use under the Permit is as follows:

RIVER PRIMARY CREEK SUPPLEMENTAL

NE 1/4 SW 1/4 4.0 ACRES 0.8 ACRE & DOMESTIC SECTION 8
TOWNSHIP 27 SOUTH, RANGE 2 WEST, W.M.

Actual construction work shall begin on or before September 28, 1993, and shall be completed on or before October 1, 1994. Complete application of the water to the use shall be made on or before October 1, 1995.

Failure to comply with any of the provisions of this permit may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the permit.
